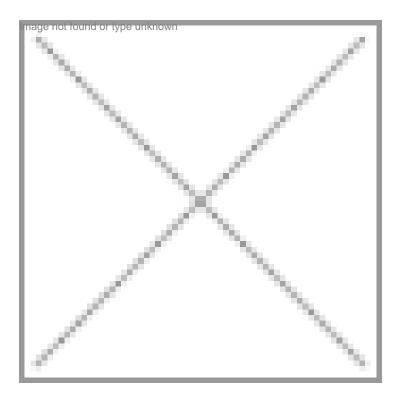


Dr Limaye becomes SCDM chair


